- Claims against Mastercard in relation to interchange fees on both cross-border and domestic transactions in 18 European countries on behalf of over 1000 operating entities in 8 corporate groups. Nicola led the Hausfeld legal team in proceedings which spanned claims in both the High Court and Competition Tribunal including a preliminary issue trial and interlocutory appeals to the Court of Appeal on issues of applicable law and relation back.
- Representing vertical search engine Foundem in its claim against Google for abuse of dominance in relation to comparison shopping services.
- Acting for a UK retailer in claims in the High Court against manufacturers of Copper Tubes and Copper Fittings
