



## Competition Law: Private Enforcement: Claimant Department – Band 1

### What the team is known for

Leading player in competition damages claims that are founded on EC decisions on price-fixing cartels or abuse of dominance. Handles cases that combine follow-on claims with additional standalone elements relating to the duration and scope of suspected cartel activities. Often brings together large claimant groups in order to pursue claims in the UK or other key jurisdictions. Has notable experience working with litigation funders on high-value cases.

### Strengths

"Their sweet spot is collective actions. If you are bringing those kinds of cases they are going to be big-ticket and the defendants will be well represented, so you need to have high-quality representation," states one interviewee, going on to note: "The firm is able to draw on its US experience where it is an obvious market leader, and I think it has helped shape the market here to a certain extent."

Another source reports: "They are able to perform an invaluable role in terms of pulling teams of economists together and having discussions with funders; they certainly have the network to handle these cases."

### Work highlights

Acted for three large claimant groups seeking to recover losses incurred as a result of the air cargo cartel. The firm assisted with UK court proceedings and with negotiations for the eventual settlement of the claims.

**Anthony Maton** is often credited with driving the success of the firm's UK competition litigation practice. "He is a really clever business lawyer who knows how to turn a problem into a solvable lawsuit," says one market commentator, while another source notes Maton's "strategic understanding of these cases."
